



## Santen's Measures to Combat Novel Coronavirus Infections (COVID-19) (No. 3)

In response to the current widespread infections with the disease caused by the novel coronavirus, Santen has made rapid global efforts throughout our worldwide operations to prevent infections from occurring and spreading while also ensuring that we continue to run a business and provide a stable supply of our products. Currently, various countries are taking gradual steps to remove restrictions on people's movements and economic activities, but rather than return to the practices that were in place before the spread of novel coronavirus, we believe that new, modified work styles must be introduced. Based on this belief, we will be taking the actions below. Note that the actions below describe our basic policies, and all measures taken by the company will follow the legal regulations and guidelines in the respective countries and regions in which we operate included Japan, China, the rest of Asia, Europe and the United States.

- 1. Policies going forward
- We will continue to uphold basic policies for stable supply of our products, prevention of further novel coronavirus infections and maintenance of innovation.
- We will continue to thoroughly incorporate measures for preventing infection into our working and business trip practices.
- 2. We will implement the following measures in countries and regions where states of emergency have been rescinded
  - 1) Working practices
  - · As a basic rule, we will continue to have employees work from home
  - 2) Business trips
  - We are continuing to prohibit overseas business trips
  - Domestic business trips in Japan may be possible with the advance permission of a supervisor if deemed necessary
  - 3) Customer visits
  - In the case of sales activities and other customer visits, departments will take their own decisions in line with certain criteria consistent with our continued implementation of thorough measures to prevent infection
  - 4) Events and meetings
  - As a basic rule, meetings will be held online. Employees will be instructed to avoid poorly ventilated spaces, crowded spaces and close personal contact.
- 3. Guidelines for using the office when coming into the office is required
  - If an employee has no choice but to come into the office, they should receive advance permission from the head of the organization.
  - The head of each organization will ensure that no more than 30% of the members of each organization are attending the office and will continue to hold meetings and

- other events online.
- At our company's places of operation in Europe, the United States, China and the
  rest of Asia, a responsible person will be designated to report to the head of risk
  management at headquarters on the implementation and monitoring of measures
  to prevent infection.

Global guidelines for using the office are as per the below. These are basic policies and we will, in accordance with the guidelines in this region, establish local rules for our places of operation as we work further to prevent infection.
