Under the three key strategies of "Profit ratio improvement in core businesses," "Expansion of new areas" and "Strengthening of foundation as a global company," Santen strives to achieve goals set out in its medium-term management plan by 2025. Based on these strategies, we are enhancing digital health potentials with a disease awareness application for consumers, and a medical education platform for healthcare professionals.
